Description of General Requirement:

The United Nations Mission in the Republic of South Sudan (UNMISS) has a requirement for the provision of Sea/inland Freight Forwarding Services from FCA-Ashdod/Haifa Israel to DAP- UNMISS Logistics Base, Juba, South Sudan and hereby solicits Expression of Interest (EOI) from qualified and interested vendors.

Conditions:

- Interested service providers/companies are invited to submit their EOIs for consideration by email (preferred), courier or by hand delivery as indicated below. The EOI must include, at a minimum, the following documentation/information:
 - (a) United Nations Global Market Place (UNGM) Registration: Company should be registered in UN Global Marketplace (UNGM) using the link https://www.ungm.org or should start their registration process immediately if not registered. Companies are strongly advised to register or upgrade to Level 1.
 - (b) Company's contact details: UNGM Identification Number, company name, address, telephone, and e-mail must be provided in the EOI Form. Failure to provide this information in the EOI Form may result in a rejection of an EOI.
 - (c) Vendors must be registered in UNGM under the services (UNSPSC No.78141501) in order to participate in the solicitation for this requirement.

Thus, submitting a response to this REOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.
