1. The United Nations Mission in South Sudan (UNMISS) hereby solicits Expression of Interest (EOI) from qualified **South Sudanese Women Group Organizations**, for the Provision of Local Cuisine Cafeteria Services to UNMISS in Juba South Sudan on a concessionary basis.

- 2. Interested companies are invited to submit their EOI by hand delivery or e-mail as indicated below. The EOI must include, as a minimum, the following documentation/information:
  - 2.1. Proof of being a South Sudanese Women Group Organization
  - 2.2. Company must be registered in UN Global Marketplace (UNGM) using the link <a href="https://www.ungm.org">https://www.ungm.org</a> or should start their registration process immediately if not registered. Companies are strongly advised to register or upgrade to Level two [2].
  - 2.3. Company's name, address, telephone, e-mail and UNGM registration number.
  - 2.4. Vendors must be registered in UNGM under the services (UNSPSC No. 90101700) to participate in the solicitation for this requirement.
