Provision of Lean Six Sigma Green Belt Certification Training for UNMISS Staff in Juba, South Sudan

1. **The United Nations Mission in the Republic of South Sudan (UNMISS)** intends to establish a short term contract for the provision of Lean six Green Belt Certification Training.

2. **Description of General Requirements:**

1. The United Nations Mission in South Sudan (UNMISS) through its Integrated Mission Training Center (IMTC) intends to conduct an in-house Lean Six Sigma Green Belt Certification Training in Juba, South Sudan. Interested service providers and its instructors must be accredited by a reputable academic institution for delivering lean six sigma programmes and green belt certification.

2. Requirement:

The course shall be provided for a targeted number of 10 participants and to be conducted in one batch in Juba (South Sudan). The recommended duration of the training will be a maximum of 14 (fourteen) days.

3. Topics of the Training shall include but not limited to the following:

Business process analysis technique; Practical knowledge and skills in managing performance management frameworks; Conceptual knowledge of risk management and Organizational change management and project management skills.
