1. Description of General Requirement:

The United Nations Mission in South Sudan (UNMISS) hereby solicits Expression of Interest (EOI) from competent Companies for Provision of Freight Forwarding Services for Sea/Inland Shipments of Spare Parts for Coelmo Generators from FCA Napoli Port, Italy, to DAP UNMISS Logistics Base, Juba, Republic of South Sudan.
