 The United Nations Mission in South Sudan (UNMISS) The United Nations Mission in South Sudan (UNMISS) hereby solicits Expression of Interest from locally registered women self-help groups to establish a Contract for the provision of Local Cuisine Catering Services to UNMISS personnel in Juba, South Sudan. Interested women self-help groups are requested to submit their expression of interest for consideration.

Requirement

- 2. The requirement shall include but not limited to the following:
 - 2.1 Provision of cafeteria services for local food during breakfast and lunch time.
 - 2.2 Installation and maintenance of equipment and furniture in UNMISS provided facilities. The winning bidder shall provide its own kitchen equipment and accessories, table and chairs and maintenance of the same.
 - 2.3 Cleaning of the facilities
- 3. The resultant contract is expected to be for an initial period of two (2) years with an option to extend for an additional period of two (2) years of one (1) year period each.

- 4. Interested service providers are invited to submit their EOIs by email, courier or hand delivery as indicated below. The EOI must include, at a minimum, the following documentation/information:
 - (a) Before submitting their EOIs, interested vendors are required to be fully registered at basic level in the UN Global Marketplace (UNGM) using this link https://www.ungm.org.
 - (b) Vendors to provide proof that they are registered for the particular requirement in UNGM under the specified UN Standard Products and Services Code (UNSPSC Code No: 90101603).
 - (c) UNMISS Procurement Section shall reject any EOI that does not contain the final UNGM vendor registration number under the specified UNSPSC code.
- 5.
