Description of General Requirement:

The United Nations Mission in the Republic of South Sudan (UNMISS) has a requirement for the Establishment of a Local System Contract for Provision of Paints and Related Products for United Nations Mission in South Sudan (UNMISS) and hereby solicits Expression of Interest (EOI) from qualified and interested vendors.

Conditions:

1. Interested service providers/companies are invited to submit their EOIs for consideration by email (preferred), courier or by hand delivery as indicated below. The EOI must include, at a minimum, the following documentation/information:
 - (a) United Nations Global Market Place (UNGM) Registration: Company should be registered in UN Global Marketplace (UNGM) using the link <https://www.ungm.org> or should start their registration process immediately if not registered. Companies are strongly advised to register or upgrade to Level 1.
 - (b) Company's contact details: UNGM Identification Number, company name, address, telephone and e-mail must be provided in the EOI Form. Failure to provide this information in the EOI Form may result in a rejection of an EOI.
 - (c) Vendors must be registered in UNGM under the services (UNSPSC No. 31210000) in order to participate in the solicitation for this requirement.

Thus, submitting a response to this REOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.~~
