**General Description of the Requirement:**

The United Nations Mission in South Sudan (UNMISS) hereby solicits Expressions of Interest (EOI) from competent Companies for the **supply and delivery of Faraday bags and lockers to UNMISS Logistics Base, Juba, South Sudan**. Faraday is a shielding technology designed to block electromagnetic signals and protect against electronic surveillance.

1. Interested companies are invited to submit their Expression of Interest (EOI) online, via email or by hand delivery as indicated below. The EOI must include, at a minimum, the following information:
  - United Nations Global Market (UNGM) and Registration Number.
  - Company's contact details (address, telephone and e-mail, etc.).

2. This REOI does not constitute a solicitation. UNMISS reserves the right to change or cancel the requirement at any time during the REOI and/or solicitation process. Thus, submitting a response to this REOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.
3. UNMISS also reserves the right to send the Solicitation Documents to companies who were identified through additional market research or other means to source the UN requirements.
4. Vendors interested in fulfilling the requirement described above must be manufacturers, authorized distributors, or authorized sellers of Faraday equipment.

6. Local and Regional companies, women owned business, and businesses by people living with disabilities are encouraged to participate.
