General Description of the Requirement:

The United Nations Mission in South Sudan (UNMISS) hereby solicits Expression of Interest (EOI) from competent Companies who are qualified and have capabilities to **provide one (1) Reach Stacker fitted with telescopic spreader with capacity to lift both 20ft and 40ft ISO sea containers**, technical support and service spare parts package. This is a one-time purchase.

Conditions:

1. Interested companies are invited to submit their Expression of Interest (EOI) by e-mail as indicated below. The EOI must include, as a minimum, the following information:
 - United Nations Global Market (UNGM) and Registration Number for supply of UNSPSC Code number 24101600 - *Lifting equipment and accessories*.
 - Company's contact details (address, telephone and fax numbers, e-mail, etc.).
