For the Provision of Sea/Inland Freight Forwarding Services from FCA- Ashdod/Haifa, Israel to
DAP- UNMISS Logistics Base, Juba, South Sudan.

Closing Date for Receipt of EOI: 26 November 2018.

Description of General Requirement:

1. The United Nations Mission in the Republic of South Sudan (UNMISS) has a requirement for the provision of Sea/inland Freight Forwarding Services from FCA-Ashdod/Haifa Israel to DAP- UNMISS Logistics Base, Juba, South Sudan and hereby solicits Expression of Interest (EOI) from qualified and interested vendors.

Conditions:

2. Interested service providers/companies are invited to submit their EOIs for consideration by email (preferred), courier or by hand delivery as indicated below. The EOI must include, at a minimum, the following documentation/information:
 - (a) United Nations Global Market Place (UNGM) Registration: Company should be registered in UN Global Marketplace (UNGM) using the link <https://www.ungm.org> or should start their registration process immediately if not registered. Companies are strongly advised to register or upgrade to Level 1.
 - (b) Company's contact details: UNGM Identification Number, company name, address, telephone, and e-mail must be provided in the EOI Form. Failure to provide this information in the EOI Form may result in a rejection of an EOI.
 - (c) Vendors must be registered in UNGM under the services (UNSPSC No.78141501) in order to participate in the solicitation for this requirement.

Important Notice:

3. This REOI does not constitute a solicitation. UNMISS reserves the right to change or cancel the requirement at any time during the EOI or solicitation process. Thus, submitting a response to this REOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.
4. The UNGM Identification Number obtained at the start of the registration process, must be provided to the Procurement officer at the time of submitting the EOI in the completed EOI Form.
