- United Nations Global Market (UNGM) and Registration Number for Air Conditioners of UNSPSC Code no 40101701.
- Company's contact details (address, telephone and fax numbers, e-mail, etc.).

- 5. Vendors already registered at the UNGM basic level are strongly advised to upgrade to level 1.
- 6. Local and Regional companies are encouraged to participate.
