#### **Description of General Requirement:**

Companies are strongly advised to register or upgrade to Level 1.
  - (b) Company's contact details: UNGM Identification Number, company name, address, telephone, fax numbers and e-mail must be provided in the EOI Form. Failure to provide this information in the EOI Form may result in a rejection of an EOI.
  - (c) Vendors must be registered in UNGM under the services (UNSPSC No.31151600) in order to participate in the solicitation for this requirement.

- 3. This REOI does not constitute a solicitation. UNMISS reserves the right to change or cancel the requirement at any time during the EOI or solicitation process. Thus, submitting a response to this REOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.
- The UNGM Identification Number obtained at the start of the registration process, must be provided to the Procurement officer at the time of submitting the EOI in the completed EOI Form.
