**Provision of ICT Infrastructure Cabling & Expendables to the United Nations Mission in South Sudan**

**Closing Date for Receipt of EOI: Thursday, 24 September 2015**

The United Nations Mission in the Republic of South Sudan (UNMISS) hereby solicit Expression of Interest (EOI) from qualified Contractors for the Provision of ICT Infrastructure Cabling & Expendables to the UNMISS Logistics Base, Near Juba International Airport, Juba, South Sudan, as stated herein.

**Description of General requirements:**

1. UNMISS seeks to procure ICT Infrastructure Cabling & Expendables i.e. Metal Boxed Drill Bit Sets; LAN Cables; Professional Tone Tracing Kits; 6U Fixed Wall Mount Cabinets; 9U Fixed Wall Mount Cabinets; Multi-tools; Fiber Patch Cords (LC/SC duplex); UTP Cat5e Patch Cords; Cat5e UTP Dual Outlets (one gang); Socket Mounting Plates (one gang); Networks Micro-scanner 4etc.
2. Companies interested in this requirement must be in a position to supply and deliver the ICT Infrastructure Cabling & Expendables on the basis of Delivered at Place (DAP) UNMISS Logistics Base, Near Juba International Airport, Juba, South Sudan (Incoterms 2010).

**Conditions**

Interested companies are invited to submit their EOI by courier, email or hand delivery as indicated below. The EOI must include, as a minimum, the following documentation/information:

1. As a mandatory requirement for UNMISS, before submitting an EOI, interested companies are required to be fully registered as a supplier on the **UN Global Marketplace (UNGM)** using the link <https://www.ungm.org>. Registration is free of charge. As you express interest in the planned solicitation by submitting your EOI, please verify and ensure that your company is registered under its **full legal name** with the **UN Secretariat** on the UNGM. We strongly recommend all companies to register at least at **Level 1** under the UN Secretariat prior to participating in any solicitations.
2. Proof that the company is registered for this particular requirement in UNGM under UN Standard Products and Services Codes (UNSPSC) 43190000; 43210000; 43202200 and/or 43220000.
3. UNMISS Procurement Section shall reject any EOI that does not contain the final UNGM vendor registration number under the specified UNSPSC as such submissions will be considered non-responsive.

This REOI does not constitute a solicitation. UNMISS reserves the right to change or cancel the requirements at any time during the REOI and/or solicitation process. Thus, submitting a response to this REOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.
