- Company's contact details (address, telephone and fax numbers, e-mail, etc.);
- Vendors are advised to upgrade their UNGM registration to UNGM Level 1 for the provision of the required items (UNSPSC Code No. 42290000-surgical products/42295400-surgical support supplies/46171645-Mobile X-ray Systems).
