1. The United Nations Mission in the Republic of South Sudan (UNMISS) has a requirement for the Construction of Conventional Water Treatment Plants in Juba, Malakal and Bentiu, Republic of South Sudan and hereby solicits Expression of Interest (EOI) from qualified and interested vendors.

Companies are strongly advised to register or upgrade to Level 2.
  - (b) Company's contact details: UNGM Identification Number, company name, address, telephone and e-mail must be provided in the EOI Form. Failure to provide this information in the EOI Form may result in a rejection of an EOI.
  - (c) Vendors must be registered in UNGM under the services (UNSPSC No. 72000000) in order to participate in the solicitation for this requirement.
