# For the Construction of Camp Entrance Security Infrastructure at various locations in the Republic of South Sudan.

### **Description of General Requirement:**

The United Nations Mission in the Republic of South Sudan (UNMISS) hereby solicits Expression of Interest (EOI) from competent companies for the construction of Camp Entrance Security Infrastructure at various UNMISS locations in the Republic of South Sudan.

### Conditions:

Interested companies are invited to submit their EOI by e-mail (preferred) or hand delivery as indicated below. The EOI must include, as a minimum, the following documentation/information:

- 1. United Nations Global Market Place (UNGM) Registration: Company should be registered in UNGM or should start their registration process immediately if not registered. Companies are strongly advised to register or upgrade to Level-2.
- Company's contact details: UNGM Identification Number obtained at the start of the registration process, company name, address, telephone, fax numbers and e-mail must be provided in the EOI Form. Failure to provide this information in the EOI Form may result in a rejection of an EOI.

- 1. This REOI does not constitute a solicitation. UNMISS reserves the right to change or cancel the requirement at any time during the EOI or solicitation process. Thus, submitting a response to this REOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.
- 2. Any interested vendor not registered in UNGM, should start the registration process immediately by visiting www.ungm.org.
- 3. The UNGM Identification Number obtained at the start of the registration process, must be provided to the Procurement officer at the time of submitting the EOI in the completed EOI Form.
