The United Nations Mission in South Sudan (UNMISS) has a requirement for the Supply and Delivery of Warehouse materials (utility blade cutter, carton opener, film cutter, heavy duty ratchet combination strapping tool, polypropylene strapping kit, 12mm open steel seals S-50LA for poly strapping, 13mm steel strapping seals for use with steel strapping tools, strapping 100lb. steel strapping coils, tensioner/cutter for 13, 16, 19mm steel strapping, convex safety mirrors, aluminum dockboards/dockplate, bolt cutter, box cutter knife, extension ladder, push broom, stack and hang bins, steel box for transportation of batteries, wheel barrow, yard utility cart) to UNMISS, Juba, South Sudan

1. Interested companies are invited to submit their EOIs for consideration by email (preferred), courier or by hand delivery as indicated below. The EOI must include, at a minimum, the following documentation/information:
  - (a) United Nations Global Market Place (UNGM) Registration: Company should be registered in UN Global Marketplace (UNGM) using the link <https://www.ungm.org> or should start their registration process immediately if not registered. Companies are strongly advised to register or upgrade to Level 1.
  - (b) Company's contact details: UNGM Identification Number, company name, address, telephone and e-mail must be provided in the EOI Form. Failure to provide this information in the EOI Form may result in a rejection of an EOI.
  - (c) Vendors must be registered in UNGM under the services (UNSPSC Nos. 24102100) in order to participate in the solicitation for this requirement.

2. This REOI does not constitute a solicitation. UNMISS reserves the right to change or cancel the requirement at any time during the EOI or solicitation process. Thus, submitting a response to this REOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.
