**For the Provision of Ready Mix Concrete to UNMISS in Juba, Republic of South Sudan.**

**Closing Date for Receipt of EOI: Wednesday 20 June 2018**

**Description of General Requirement:**

The United Nations Mission in the Republic of South Sudan (UNMISS) hereby solicits Expression of Interest (EOI) from competent companies for the supply and delivery of ready Mix Concrete to UNMISS in Juba, Republic of South Sudan.

**Conditions:**

Interested companies are invited to submit their EOI by e-mail (preferred) or hand delivery as indicated below. The EOI must include, as a minimum, the following documentation/information:

1. United Nations Global Market Place (UNGM) Registration: Company should be registered in UNGM or should start their registration process immediately if not registered. Companies are strongly advised to register or upgrade to Level-2.
2. Company's contact details: UNGM Identification Number obtained at the start of the registration process, company name, address, telephone, fax numbers and e-mail must be provided in the EOI Form. Failure to provide this information in the EOI Form may result in a rejection of an EOI.

**Important Notice:**

1. This REOI does not constitute a solicitation. UNMISS reserves the right to change or cancel the requirement at any time during the EOI or solicitation process. Thus, submitting a response to this REOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.
2. Any interested vendor not registered in UNGM, should start the registration process immediately by visiting [www.ungm.org](http://www.ungm.org).
3. The UNGM Identification Number obtained at the start of the registration process, must be provided to the Procurement officer at the time of submitting the EOI in the completed EOI Form.
